TERMS & CONDITIONS			

Please review the following policies: safety, membership, refund, photograph/sound/video release; waiver of liability, and consent for medical treatment and then sign below to agree to TFC Terms & Conditions.

SAFETY POLICY:

- The fencing floor is restricted to fencers only. Non-participants must stay in the observation area
- Fencing weapon must be carried with points down or in a fencing bag
- Any illness, injury, or medical problems must be reported to the coach before lesson/practice starts, or during the stay of Tizona Fencing Club(TFC)
- Warm up and stretches are required before a lesson or practice. Arrive 15 minutes early for it

- Rough play or dangerous actions are prohibited whether intentional or not
- Walking or standing close to the fencers when blades are raised or in motion is prohibited
- Mask, glove, fencing jacket, knickers, plastron, breast plate for female, and athletic shoes must be worn when fencing
- Any person not abiding by TFC rules may be subject to expulsion

MEMBERSHIP POLICY:

- Membership starts from the date you sign the Membership Form and payment is received.
- To be considered a member, you must pay on an annual or weekly basis. Weekly Membership fees are non-refundable.
- Additional Family Member Rate is applicable to younger family members only when oldest family member pays First Member Rate.
- If two Tizona Fencing Club (TFC) members are competing against each other in same competition, they cannot be strip coached by any coach or friend from any club.
- TFC members must represent TFC as their primary club on their FV and AFF registration, at any FV and AFF-sanctioned competitions.
- TFC members must wear TFC uniform or TFC tracksuit at competitions.

REFUND POLICY:

50% refunds

If you join the Tizona Fencing Club and drop out within 3 months, you will be eligible to receive a 50% refund.

No refunds

If you join the Tizona Fencing Club and drop out after 3 months, you will not be eligible to receive any refund.
